# ECONOMICS AND ECONOMIC POLICY (ENGLISH)

The purpose of this programme is to prepare students for future work in academia, government agencies, private companies, and centers for economics analysis. Graduates of the Applied Economics track are trained to forecast and analyze the consequences of decisions in the fields of public policy or company policy. Research track provides thorough knowledge of economic theory and methods to carry out advanced theoretical and empirical research and prepares students for the future academic career.

## STRATEGIC CORPORATE FINANCE (ENGLISH)

The programme focuses on studying the contemporary theory and global practices involved in corporate finance, as well as fundamental knowledge in all areas of finance and economics, which ensures that graduates have wide career options. Our alumni work at leading consulting companies, investment banks, M&A advisory firms, investment funds, companies of the real sector, and research centers.

Our faculty include leading Russian academics, professors from Western universities, and finance practitioners from some of the largest international companies. In just two years, students build their own personal professional network with our aid and guidance.

# MASTER IN BUSINESS ANALYTICS (ONLINE, ENGLISH)

Students are offered cutting-edge concepts and methods of business analytics and strategic reporting driven by the principles of regenerative finance, inclusive capitalism, and enhanced value creation for financial and non-financial stakeholders.

The Master in Business Analytics programme's areas of focus correspond with the new competencies that transnational employers seek in the knowledge economy and the sustainable development of countries and companies in uncertain times. The curriculum covers the following topics within a global scope: new trends in value creation analysis involving non-financial capitals of a company, their disclosure, as well as auditing and assurance strategies.

## HOW TO APPLY

**The online application cycle runs from NOVEMBER 1ST to JULY 1ST ([hse.ru/admissions](https://hse.ru/admissions)).** We encourage you to begin the process early for priority funding consideration. Based on academic merit, applicants will be offered full or partial scholarships. All applicants should prepare for a Skype interview.

### **Preparatory Year for Russian Language**

International students are offered up to 15 months of intensive study to improve their basic language skills, focus on a chosen academic field (humanities, economics, or engineering), and adapt to the new educational environment. Graduates are eligible for a 25% discount on degree programmes.

### **Related Fees**

Graduate programme tuition and fees: 195,000 – 390,000 Rubles (approx US \$2,500 – 5,000) per academic year; rent, meals, city transportation, and entertainment about US \$700 monthly.
