## Economics and Economic Policy (English)

The purpose of this programme is to prepare students for future work in academia, government agencies, private companies, and centers for economic analysis. Graduates of the Applied Economics track are trained to forecast and analyze the consequences of decisions in the fields of public policy or company policy. Tracks "Economic Research" and "Behavioral Economics" provide thorough knowledge of economic theory and methods to carry out advanced theoretical and empirical research and prepare students for the future academic career.

## Strategic Corporate Finance (English)

The programme focuses on studying the contemporary theory and global practices involved in corporate finance, as well as fundamental knowledge in all areas of finance and economics, which ensures that graduates have wide career options. Our alumni work at consulting companies, investment banks, M&A advisory firms, investment funds, companies of the real sector, and research centers. Our faculty include leading Russian academics, professors from Western universities, and finance practitioners from some of the largest international companies. # Master in Business Analytics (Online, English)

Students are offered cutting-edge concepts and methods of business analytics and strategic reporting driven by the principles of regenerative finance, inclusive capitalism, and enhanced value creation for financial and non-financial stakeholders.

The Master in Business Analytics programme's areas of focus correspond with the new competencies that transnational employers seek in the knowledge economy and the sustainable development of countries and companies in uncertain times. The curriculum covers the following topics within a global scope: new trends in value creation analysis involving non-financial capitals of a company, their disclosure, as well as auditing and assurance strategies.

## How to Apply

### Online application opens **NOVEMBER 1ST** at [hse.ru/admissions](https://hse.ru/admissions)

Apply early for priority funding consideration. Based on academic merit, applicants will be offered full or partial scholarships.

Applicants should prepare for an online interview.

### Preparatory Year for Russian Language

International applicants are offered up to 10 months of intensive study to improve their basic language skills, focus on a chosen academic field (humanities, economics, or engineering), and adapt to the new academic environment. Graduates are eligible for a 25% discount on degree programmes.

### Scholarship Benefits and Related Fees

Full scholarship students do not pay tuition and are offered a subsidized dormitory accommodation. Partial scholarship is up to 50% of the tuition fee. Students can arrange accommodation via the Student Housing Office. All students get free books and internet on campus, as well as subsidized transit card.

Average amount of basic expenses varies between 15,000 and 20,000 RUB per month. International students are allowed to work in Russia.
