Economics & Economic Policy (taught in English)

The purpose of this programme is to prepare students for the future work in academia, government agencies, private companies, and centers for economic analysis. Graduates of the applied economics track are trained to analyze and forecast consequences of decisions in business and public policy. Research track provides thorough knowledge of economic theory and methods to carry out advanced theoretical and empirical research and prepares students for the future academic career.

Strategic Corporate Finance (taught in English)

This programme is designed for those who want to gain a deep understanding of finance and its many applications. While the focus is on corporate finance, the programme has a balanced curriculum covering macroeconomics, microeconomics, econometrics, quantitative finance, behavioural finance, and many more. Graduates of the programme work at leading consulting groups, investment banks, M&A advisory firms, and investment funds in Moscow, London and other global financial centers. Some pursue careers as strategy consultants, buy-side analysts, and portfolio managers, while others develop their own businesses, conduct academic research, and work as CFOs in real sector companies.



Strategic Corporate Finance

Master in Business Analysis (online, in English)

Students are offered cutting-edge concepts and methods of business analytics and strategic reporting driven by the principles of regenerative finance, inclusive capitalism, and enhanced value creation for financial and non-financial stakeholders. The programme's areas of focus correspond with the new competencies that transnational employers seek in the knowledge economy and the sustainable development of countries and companies in uncertain times. The curriculum covers the following topics within a global scope: new trends in value creation analysis involving non-financial capitals of a company, their disclosure, as well as auditing and assurance strategies.

Benefits and Related Fees SCHOLARSHIP

Full scholarship students do not pay tuition and are offered a subsidized dormiory accommodation. Partial scholarship is up to 50% of the tuition fee. All students get free books and Wi-fi on campus, as well as subsidized transit card. Average amount of basic expenses is about 20,000 RUB per month.

International students are allowed to work in Russia.

Free one-year training of RUSSIAN LANGUAGE

International applicants are offered 10 months of intensive study to improve their basic language skills, focus on a chosen academic field (humanities, economics, or engineering), and adapt to the new academic environment.

Graduates are eligible for a 25% discount on degree programmes.
